This Agreement is for the rental of a photo booth to be attended by an agent of Magic Photo Booth 4u for the following event:

Customer represents there is good and clear access (no stairs) to the site where the photo booth will be set up, and an adequate 120 volt power outlet within 20 feet of the desired photo booth location.

Access to the desired location must be by paved walkway or other similar surface and the actual area where the photo booth will be located must be on a solid level floor. If any exceptions to these

requirements are requested by the Customer to this provision, notice must be given and an opportunity for inspection and approval by a Magic Photo Booth 4u staff member undertaken at least 60 days prior to the event. If

these conditions are not available, Magic Photo Booth 4u may either cancel this Contract and return any deposit or it may charge an additional amount for set up and removal of the booth.

The Customer agrees that he/she will be responsible for any damage done to the photo booth by any of Customer's guests.

Magic Photo Booth 4u agrees that it will staff the booth with an operating attendant (OWNERS) and that it will provide

pictures for occupants of the booth without the necessity of paying money for each picture. Magic Photo Booth 4u will provide all and supplies necessary for the event. This Agreement covers rental of the photo booth for a maximum of ____ hours. Additional time may be purchased for \$100 per hour, due and payable at or before the time of service. Magic Photo Booth 4u will timely deliver and set up the photo booth and remove the photo booth in a timely manner after the event is concluded. As part of the rental and service provided in this Agreement, Magic Photo Booth 4u Photo · will · will not provide a photo album for the customer and Magic Photo Booth 4u will · will not · provide a computer memory stick or other similar device that will contain electronic copies of all photographs taken during the rental period. Customer and Magic Photo Booth 4u agree that in the event of a mechanical failure or other problem that prevents the photo booth from properly functioning, Magic Photo Booth 4u maximum liability for a total failure to perform is to return any of the payments received. If only partial services are provided due to a mechanical failure or conditions beyond Magic Photo Booth 4u reasonable control, then the charges are to be prorated. As an example, if the rental is for a four hour period and only two hours of use are provided, then the cost of the price for this Contract will be reduced by 1/2. A deposit is required to hold the date. A deposit of 1/2 of the rental amount is due at the time of entering into the Agreement and holding the date. The balance of the contractual price is due 10 days prior to the event. If the balance is not timely paid, the deposit will be forfeited and the photo booth reservation will be canceled without further notice. If the event is canceled by the Customer more than 60 days prior to the date of the event, 1/2 of the deposit will be refunded.
